NOTICE OF ANNUAL MEETING OF THE SHERWOOD FOREST COMMUNITY CLUB

The annual meeting of Sherwood Forest Community Club will be held Wednesday, October 28, 2015, at 7:00 PM in the Library at Interlake High School, 16245 N.E. 24th Street, Bellevue, Washington.

The purpose of the annual meeting is to elect the Board of Directors and Officers of the Sherwood Forest Community Club for the 2015-2016 term, to update the membership on local issues (Communication, Traffic, Land Use, Block Watch), to approve the amount of membership dues for the fiscal year 2016, and to discuss SFCC future issues and direction.

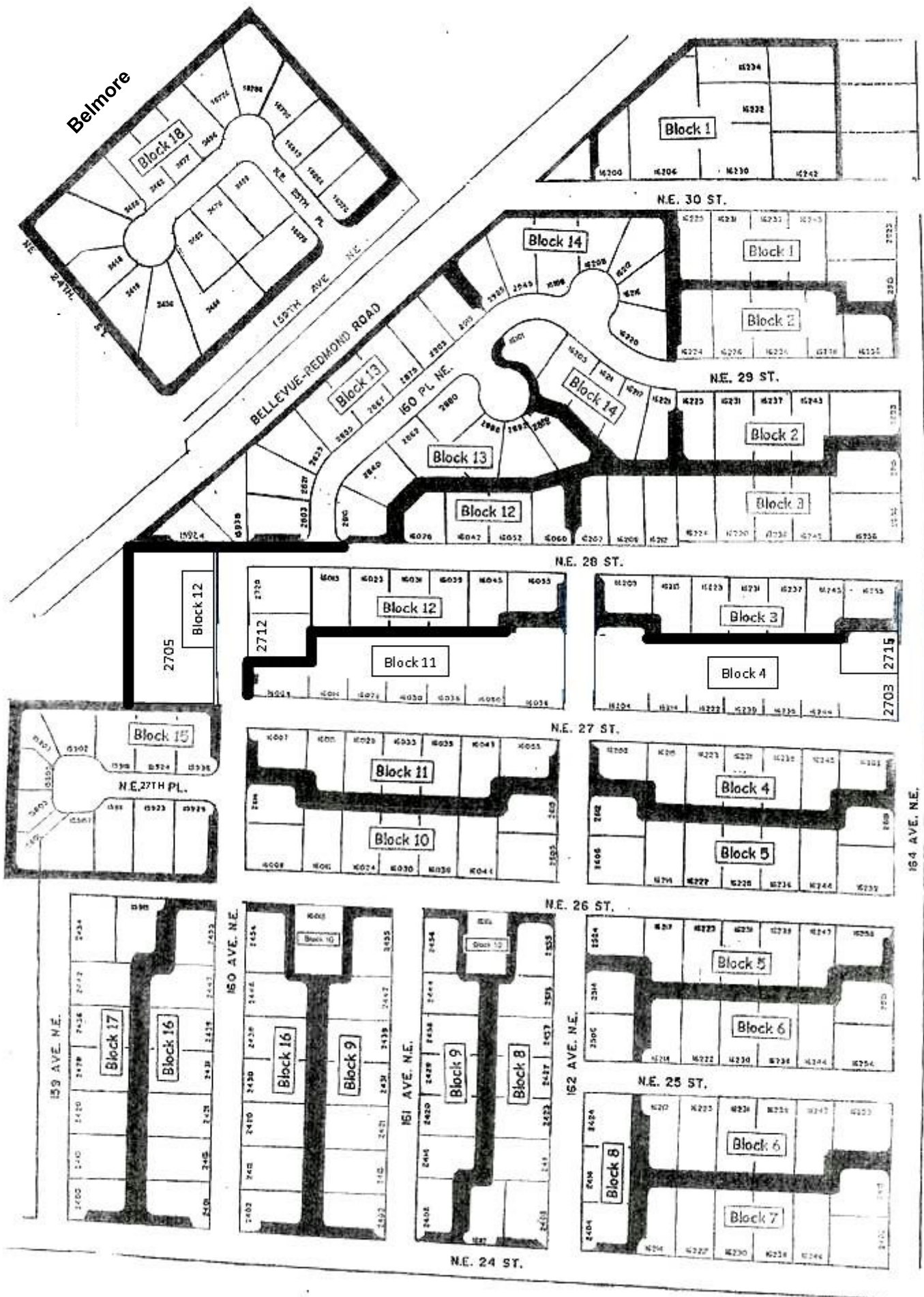

Sherwood Forest is your Community Club

Since 1958, SFCC has been involved in land use and traffic issues/studies that had the potential to adversely impact the greater Sherwood Forest neighborhood, including development projects (Microsoft, Unigard, Extended Stay hotel, Odegaard-Gockel building, Chevron station, Mission Health Care, Interlake High School, PSE substation, Angelo’s Nursery site, Walgreen’s) and traffic (NE 24th St., 164th Ave., NE 30th St., Bel-Red Rd., 156th Ave.) During that period, when residents volunteered to assist, SFCC was successful in affecting the outcome.

Although land use and traffic issues continue to potentially impact this neighborhood, the declining involvement of SFCC residents in recent years has eroded the ability of SFCC to be responsive and influential. Currently, redevelopment of the former Group Health site is underway (1,400 residences, 1.2 million square feet of office and retail a hotel, and conference center.) A proposal has been submitted by Koll Limited Edition to redevelop property bordered by NE 24th/152nd Ave./Northup Way/Sears (more than 1.05 million square feet including 700 multi-family units, a hotel, and office and retail space.) The site is adjacent to/near Bellevue land, roads, and schools. The potential impacts, particularly traffic congestion, are staggering. Further, there may be future proposals for redevelopment of parcels near/adjacent to Sherwood Forest that would increase building height and density. Will SFCC be in a position to even consider the impacts of redevelopment in this immediate area or respond to same?

Election of new Board members is scheduled to occur at this upcoming SFCC annual meeting. This year we do not have candidates for all open Officer positions, and without officers SFCC will be challenged to remain active in 2016. Special knowledge or skills are not required, the tasks are not difficult.

Without volunteers to serve as Officers and on committees, SFCC will not have the ability to carry on community club business and will not be able to meet the requirements of State non-profit incorporation. This community club, founded in 1958, has been for decades, a strong, respected, and effective voice in Bellevue and Redmond.

Numerous volunteers have served not only SFCC as Board members, Block Representatives, committee members, etc., but also served the City of Bellevue (a Mayor, Planning Commissioners, Transportation Commissioner, and City-appointed representatives to land use and traffic study groups.)

SFCC depends upon the involvement by the very members it was incorporated to serve – the residents of Sherwood Forest, Sherwood Gardens, Peachtree, and Belmore. SFCC cannot be effective without the involvement of its residents.

The upcoming annual meeting is your chance to continue the influential voice of SFCC in this community.

Nominate yourself to participate on the board on the attached ballot and mail it in or bring to the annual meeting.

The outcome is up to you.
